#### Interested In A Law Enforcement Career? Join the Suffolk County Sheriff's Department

A career within the Suffolk County Sheriff's Department requires great professionalism, a tremendous amount of responsibility, and a vast amount of integrity, judgement and sound decision-making skills. The Suffolk County Sheriff's Department is currently searching for gifted individuals who can demonstrate the previously listed qualities to be considered for our Correction Officer Training Academy.

In order to be eligible for the upcoming academy, applicants must be at least 21 years old, a United States citizen and possess a Massachusetts driver's license, as well as a high school diploma or the equivalent. Interested applicants should visit our website at: www.scsdma.org and fill out an application, which can be found in the Human Resources Division's page. After filling out the application, if you qualify, you will then be invited to take our written exam as well as a physical fitness test. Training is extensive and consists of instruction in, among other subjects,

report writing, firearms/chemical agents, physical fitness, and arrest and control, and more. As a trainee you will be expected to gain knowledge and understanding of the current departmental policies and procedures. Throughout your academy experience an emphasis will be placed on developing the positive and effective communication skills required to work in a correctional environment.

In addition to providing care, custody and control of inmates and detainees, our officers are able to pursue a diverse array of positions in law enforcement. For example, our officers transport and process hundreds of inmates and detainees. work as members of the Sheriff's Escort and Response Team (SERT), work with canines, visit schools as a members of our Choice Officer Program, and work special assignments in partnership with other law enforcement agencies, such as the Federal Bureau of Investigation, Boston Police Department, U.S. Marshals Service, and much more. ## **Meet Susan Grimes**


"At the Department, we are constantly looking for people who care about our mission and about helping our population to transition back into society," - Grimes

## **ENDING LICENSE SUSPENSION**

Sheriff Steven W. Tompkins was on hand to witness Massachusetts Governor Charlie Baker's signing of a law that repeals the automatic license suspension for people convicted of drug crimes. Prior to the signing, those convicted of drug offenses were subject to license suspensions that could last up to five years – even after the completion of their sentence – and were made to pay a reinstatement fee of \$500 to have their licenses restored. Sheriff Tompkins applauded the change alongside other staunch advocates of the law, including Senate President Stan Rosenberg, Senator Harriette Chandler, Senator Sonia Chang-Díaz, Representative Liz Malia, Representative Russell Holmes and several other elected officials and members of justice reform organizations.



## **BATTLING** Opioid and heroin use

Juffolk County Sheriff's Department's Assistant Deputy Superintendent (ADS) Rachelle Steinberg did a presentation for the Winthrop Police Department, to discuss programming within the Department's facilities, to address the growing opiate epidemic and prescription drug abuse and addiction in general .During her presentation to the Winthrop Police Department, ADS Steinberg detailed intervention services and reentry programming, and also efforts that have been designed to enhance partnerships between agencies as they work together in a greater capacity.

ADS Steinberg also provided a description and overview of

operations, in addition to some of the 80 programs provided to the incarcerated population, in an effort to increase public safety and reduce recidivism. Among the highlights that ADS Steinberg provided, the Department's use of Vivitrol and Narcan were discussed.

Additionally, ADS Steinberg, described the use of Narcan, an emergency treatment for an opioid overdose, and the steps that follow during an opioid overdose reversal. Currently within the Department's staff, transportation officers, and 900 inmates have been trained in the use of Narcan.


Speaking on the topic of drug use and addiction, Sheriff Steven W. Tompkins stated, "In my Jail and House of Correction, north of 85 percent of all inmates and detainees are committed for issues stemming from drugs or alcohol, or both." To meet the considerable challenges presented by these troubling numbers, the Department has increased inmate access to substance abuse treatment.
